3. Almon Park Pavilion Project.  
Committee members will board county van and travel to Almon Park to inspect the pavilion construction. No business will be conducted while the committee travels to and from Almon Park.
4. Upon returning to the Courthouse, the Committee will reconvene in Committee Room #1 on the second floor.

It is anticipated that the committee may consider a motion to adjourn into closed session pursuant to section 19.85 (1) (e) deliberating or negotiating the purchasing of public properties, the investing of public funds, or conducting other specified public business, whenever competitive or bargaining reasons require a closed session, and 19.85(1)(g) conferring with legal counsel for the governmental body who is rendering oral or written advice concerning strategy to be adopted by the body with respect to litigation in which it is or is likely to become involved. The issue to be discussed is the Almon Park Pavilion Project.
