Non-rep/Elected Official Health Insurance Contributions

The committee discussed health insurance contributions by non-represented employees and elected officials for 2011. The Deputy Sheriff Union agreed to an increase from a 5% to an 8% contribution for health insurance for 2011. Young presented data to the committee regarding what other counties have for employee contributions.
