Call to order.

Chairman Gary Baier called the meeting to order at 1:00 P.M., in accordance with the Wisconsin Open Meeting Law.

Discussion/decision of the agenda.

Motion by John Hoffman, second by Tom Rudolph to approve the agenda. With all members present voting "aye", the motion carried.

Discussion/decision of the meeting minutes.

Motion by Harland Lee, second by Don Sidlowski to approve the June 30, 2010 meeting minutes with one correction. With all members present voting "aye", the motion carried.

Election of Vice-Chair.

John Hoffman nominated Billy Fried to fill the position of Vice Chairman, second by Mike Timmons. John Hoffman then made a motion to close the nominations, second by Harlan Lee. With all members present voting “aye”, the motion carried.

Review final draft of Oneida County Comprehensive Plan.

The Committee sent a Resolution to the County Board of Supervisors to send the Comprehensive Plan to Public Hearing. The discussion was that the Committee wanted to wait until they heard from the three Townships that had not turned in their plans. Those Townships are Schoepke, Enterprise and Lynne. Mr. Jennrich has not heard from the Townships but he has sent them a letter asking for their plans. Mr. Baier said he spoke with all three Townships. The Town of Lynne is holding a Public Hearing on January 19, 2011. Enterprise will be having their meeting in early February and Schoepke plans to have their plan ready, at the latest, in early March.

A motion was made by Don Sidlowski that the Committee authorize the Zoning Director to send a letter to the three Townships, (Enterprise, Lynne and Schoepke), informing them that the deadline date for submission of their plan is April 1, 2011, second by Tom Rudolph. With all members present voting “aye”, the motion carried. Mr. Jennrich will also let the rest of the Towns know that if they have any changes in their plans that they will be due on April 1, 2011 as well.

Set date for Public Hearing.

A motion by Tom Rudolph that the Public Hearing be held on May 17, 2011 in conjunction with the County Board meeting, second by Mike Timmons. With all members voting “aye”, motion carried.

Approve future meeting dates. The Committee will plan to meet on April 8, 2011 to review and approve the final draft of the Oneida County Comprehensive Plan.

Public comments.

There were no public comments.

Future agenda items.

Review and approve the Oneida County Comprehensive Plan on April 8, 2011 and hold a Public Hearing on May 17, 2011.
